- No person under the age of 16 and / or without a valid drivers license are permitted the use of the golf cart at anytime.
- Golf cart must stay back 30 feet from greens, tees and water hazards at all times.
- No cart is permitted on levees at any time.
- Drive carefully. Maintain a firm grip on the steering wheel at all times. Do not spin wheels.
- Golf cart parking brake must be engaged and set before leaving golf cart.
- Old River Golf Course reserves the right to refuse the use of carts to any person not following these and other rules without refunding fee.
- If not told otherwise, always use the 90 degree rule with said golf cart.
- The renter and / or renters are financially responsible for any damage done or cause by ill use and / or miss use of said golf cart resorting in damage to the golf course, golf cart and / or persons.

I HEREBY AGREE TO PAY FOR ANY DAMAGES THAT ARE SUSTAINED TO THE BELOW GOLF CART WHILE IN MY POSSESSION AND ASSUME ALL RISK OF OPERATING THE CART. I REPRESENT THAT I AM FAMILIAR WITH THE OPERATION AND USE OF SAID GOLF CART AND THAT I CAN OPERATE AND CONTROL SAME AND WILL FOLLOW ALL CART OPERATION RULES. I PROMISE AND FURTHER AGREE TO INDEMNIFY AND HOLD LESSOR, ITS ASSIGNEE AND THE GOLF COURSE FREE AND HARMLESS FROM ANY DAMAGE OR CLAIMS OF ANY NATURE WHATSOEVER THAT MAY ARISE FROM OR THROUGH THE USE OF SAID CART.
